

Section Two Standing Rules

Standing Rules of the Fraternal Order of Police of Ohio, Inc. Annual Conference of 2025

- Rule 1. (a) The Credentials Committee, as the first order of business, shall report the number of delegates and alternates registered as present with proper credentials and shall make a supplementary report after the opening exercises at the beginning of each day that business continues. No other business may be conducted until the Credentials Committee report is adopted by the body.
- (b) A member registered as an alternate may be transferred from alternate to delegate at any time during the business meeting on Monday, July 14th.
- (c) A member registered as an alternate may be transferred from alternate to delegate by 9:30 a.m. on Tuesday, July 15th, for purposes of conducting business on Tuesday, July 15th.
- Rule 2. The standing rules of the conference shall be considered as the second order of business.
- Rule 3. For admission to the conference room where the business of the FOP of Ohio, Inc. is being conducted, delegates, alternates and guests shall be required to wear the badge issued by the Credentials Committee upon registration.
- Rule 4. A resolution offered by an individual delegate shall be in writing, signed by the maker and the seconder, each of whom shall be a voting member of the conference, and shall be sent directly to the Chairman of the Resolutions Committee.
- Rule 5. A delegate must obtain the floor and be recognized by the presiding officer before beginning to speak.
- Rule 6. A delegate can speak twice to a motion on the same day, but he or she can take the second turn only after everyone who wishes to speak the first time has spoken. If debate on the motion is continued at the next meeting, which is held on another day, the delegate's right to debate is renewed.
- Rule 7. Speakers must address all remarks to the chair; cross talk between delegates is not allowed.
- Rule 8. Speakers must be courteous and never attack other delegates or question the motives of the delegates. In controversial issues, the discussion is focused on ideas, not personalities.

2025 Conference Report President Jay McDonald

Brothers and Sisters,

I would like to welcome you to the 89th Annual Conference of the Fraternal Order of Police of Ohio, the oldest State Lodge in the Fraternal Order of Police. Thank you so much for being delegates and alternates at this conference and doing the work of the Order!

VIOLENCE AGAINST POLICE

Since July 24, 2024 when we last met as a state conference until July 7, 2025 when this report submitted, 108 of our Brothers and Sisters have died in the line of duty. In 2024, 49 officers were killed by gunfire, 12 by vehicular assault and 20 by vehicle accident. These numbers tell a story of the violence directed at our members...but not the whole story. The numbers of officers who are shot but survive that attack are unfortunately rising and rising dramatically. The National FOP reported on July 1 that the number of officers shot in the line of duty in 2025 is 166, 45 were shot in ambush style attacks. 21 American law enforcement officers have already been killed by gunfire in the first five months of the year. 342 officers were shot in the line of duty in 2024.

I was able to attend the Ohio and National memorials for our Brothers and Sisters who died in the line of duty in 2024. The FOP of Ohio was also well represented at the funerals of Deputy Henderson and Deputy Sherrer this year.

The State of Ohio memorialized the following officers at the 37th annual Ohio Peace Officers Memorial Ceremony:

I want to thank all of the local lodges that held memorials to fulfill the promise that we will never forget the sacrifice made by our fallen Brothers and Sisters in service to their communities.

PROTECT OHIO POLICE

On June 5, 2025, the FOP of Ohio held an historic press conference to launch a new initiative called Protect Ohio Police. This new initiative was formulated in response to the disgusting increase in violence directed towards our members in the month of May. Earlier in this report, I discussed the murders of Deputy Larry Henderson and Deputy Daniel Sherrer in May of 2025 but two Mifflin Township (Franklin County) Officers were shot in May, officers were shot at in Union County; Medina County and in Ashland County in a sport span of time during May of 2025. This initiative was formed to demand action to combat this increase in violence and the outrageous narrative that violence against the police is somehow acceptable. We made a list of demands at this press conference. They were:

- We demand that <u>CITIES</u> adopt local laws that protect cops.
- We demand that <u>MAYORS</u> stop criticizing police when they do their job as trained.
- We demand that **JUDGES** set bail that protects the community.
- We demand that **PROSECUTORS** stop cutting deals that put violent criminals back on our streets.
- We demand that **LEGISLATORS** increase penalties for violence against police.

If these demands are not met, the FOP of Ohio will:

- Grade elected officials on their commitment to Protect Ohio Police. And then we will publicize the results.
- If these elected officials don't respond effectively, we will recruit challengers to them and defeat them in elections. This starts by electing members of the FOP of Ohio to elected office.
- We will raise the money needed and mobilize tens of thousands of Ohioans needed to replace them at the ballot box.

At this conference, we will talk about recruiting FOP members to run for elected office, the creation of a web site where we will hold elected officials accountable (protectohiopolice.com) and the creation of a Super PAC where local lodges and the state lodge can dedicate resources to helping elect or unelect politicians. This is the end of complaints without action but we need all local lodges and all members to be united in our effort to stand with the men and women who protect and serve our streets.

2024 LEGISLATIVE ACTION

In the fall of 2024, the FOP of Ohio had two main legislative priorities. The Social Security Fairness Act in Congress and HB 296. We used every communication tool available to us to encourage our members to get engaged in the effort to pass these two important pieces of legislation.

On the federal level, you will hear from President Yoes about the passage of the Social Security Fairness Act. However, I want to talk about the actions taken here in Ohio to help pass that historic law. We worked with senator Sherrod Brown, the lead sponsor of the bill in the US Senate, to hold a field hearing on the topic that drew hundreds of public employees top the hearing and attention to the issue from the media. Several letters were sent from the FOP of Ohio to every member of the Ohio congressional delegation lobbying for the effort. Vice President Assion and I went to D.C., and visited every Ohio member of the U.S. House on the day of the vote for the Social Security Act and were the only law enforcement officers in the country who were present in the gallery to witness the historic vote. Every Ohioan voted in favor of the Social Security Fairness Act, even those who told us earlier in the day that they would not vote for it. Your work, calling and emailing your congressional representatives made that happen. This is not our guess, this is what the members of Congress told us.

HB 296, a bill to equalize the employer contributions to the Ohio Police and Fire Pension Fund passed the Ohio House in the lame duck session of the General Assembly by a vote of 66 to 25(there were 8 members who did not vote). Our pressure campaign with the Ohio Association of Professional Fire Fighters got us closer than ever to achieving this important goal. The FOP of Ohio worked to get our members, and our families engaged in the effort. In addition to calling and emailing our elected leaders, we even held a mini-lobby day at the Statehouse in conjunction with the firefighters to work towards passage of HB 296. However, in the Ohio Senate, we were unable to get the bill on the floor before the end of the General Assembly. We faced massive opposition from the Ohio Municipal League and the Ohio Mayor's Alliance on this issue. In fact, OML called our effort to have the employers pay their fair share of the pension

costs "the largest unfunded mandate in Ohio's history." We continue to work on this bill.

FOP OF OHIO 2025-2026 LEGISLATIVE GOALS

With the new General Assembly, the legislative committee established the following goals for 2025-2026:

- The equalization of our employers contribution to the Ohio Police and Fire Pension Fund. This has become HB 280.
- The establishment of a DROP plan for our members in the Ohio Public Employee Retirement System. This has become HB 73. Fixing transfer credits for members in OPERS also remains a priority.
- To arm the state law enforcement officers of the Ohio Department of Developmental Disabilities and the Ohio Department of Mental Health.
- PTSD treatment and using money from recreational marijuana taxes to pay for this important benefit.
- Civilian Review Boards and developing guardrails for these entities such as background checks; mandated training on the use of force, etc...
- Due process for our members in Brady list situations.

The first half of 2025 has been focused on the Ohio budget and trying to get the first three issues included in this legislation. We prepared a package of amendments to cover each of these important topics, found legislators to introduce the amendment but were ultimately unsuccessful in getting them included. We will now pursue stand alone bills for these and many other topics.

Please see the legislative report in this package to see other bills we are focused on, either in support or in opposition.

NFOP LEGISLATIVE PRIORITIES

We will talk a lot about the legislative efforts of the FOP of Ohio, but we do not spend as much time on the efforts of congressional legislation. So, as of July 7, 2025...here are the Ohio co-sponsors of the NFOP priority legislation:

 Public Safety Employer Cooperation Act (collective bargaining) (HR 1505 / S. 636)

- o US House 40 co-sponsors- Ohio co-sponsors: Greg Lansdman
- o US Senate 1 co-sponsor. Neither Ohio Senator has signed onto this bill

Law Enforcement Officer Equity Act (HR 3226)

- o US House: 29 co-sponsors; Turner only Ohioan on bill
- US Senate: Not yet introduced

Protect and Serve Act (HR 1551 / S. 167)

- o US House 81 co-sponsors; Balderson; Carey; Landsman; Miller; Rulli; Turner called and said he was getting on the bill but hasn't done so yet
- o US Senate 18 co-sponsors: Moreno; Husted

LEOSA Reform Act (HR 2243 / S. 679) - PASSED THE HOUSE!

- o US House Ohioans who voted yes: Balderson; Carey; Davidson; Jordan; Joyce; Kaptur; Landsman; Latta; Miller; Sykes; Turner; Wenstrup. Ohioans who voted no: Beatty; Shontel Brown; Sykes.
- o US Senate 8 Co-sponsors Moreno and Husted indicated support but not yet signed onto the bill

The HELPER Act (HR 2094 / S. 978)

- o US House 71 co-sponsors. Ohio Co-sponsors: Shontel Brown; Sykes; Turner
- o US Senate 18 co-sponsors. Neither Ohio senator has signed onto the bill

We are also working with Rep. Landsman from Cincinnati on reintroducing Medicare at age 50 for retired 1st Responders.

QUALIFIED IMMUNITY

Proponents of eliminating Qualified Immunity need 413,487 valid signatures from at least 44 counties and are aiming for the 2026 ballot. They have not filed a campaign finance report, indicating that they have not raised substantial revenue. They do not have an established group with political muscle backing them as of now.

Follow the playbook from Senate Bill 5

- Build coalitions Unions; Police and Fire groups; Mayor's Alliance; elected
 officials and others have all reached out to work with us to defeat the
 proposal
- 2. Engage Experts Communications Counsel and Bob Paduchik remain on our team
 - ·Lodges should be building social media; gathering emails/phone numbers; beginning to think about financial resources; making sure members are registered to vote

Here is where the FOP of Ohio is:

- 1. FOP of Ohio War Chest has funds that have been building since SB 5
- 2. FOP of Ohio will begin Social Media Efforts to build more followers
- 3. FOP of Ohio will work with local lodges to build bigger email/app database

<u>MESSAGING</u>: Until we get direction saying otherwise informed by polling/testing, we are using:

- Eliminating Qualified Immunity will raise taxes, increase crime and devastate the number of people willing to serve their community.
- Eliminating Qualified Immunity hurts not just law enforcement, it targets those who educate our children, care for our elderly, and all other public employees

Remember, there are two kinds of messaging;

- ·To members, tell how it impacts them, so they understand the risk
- ·To the public and on our social media/in press, laser focus on how it impacts the community as a whole and not on us

THIN BLUE LINE BENEFITS

I want to start by thanking State Fop Secretary Travis Parker for all his work with our members who have experienced issues with Thin Blue Line Benefits. Secretary Parker was the main contact between members and TBL in regard to complaints received by the FOP of Ohio. Here is a timeline of events regarding our members' complaints regarding TBL and our response.

- The marketing agreement between the FOP of Ohio and TBL was approved by the delegates of the Sandusky conference in 2023.
- We began to get complaints in the fall of 2024
- We invited TBL to address our Board and members at our January Board meeting, to answer questions and try to get a handle on the issues.
 Complaints continue
- We met with TBL in Nashville in February of 2025 Complaints continue
- The Ohio FOP and National FOP met with TBL in Salt Lake City in March of 2025. We continue to get complaints
- We work with OP-F in April to ensure that our members who are negatively impacted can switch without penalty if they meet certain criteria set by the federal government
- It was decided at our next Ohio FOP Board meeting to cancel the marketing agreement in early May.
- The marketing agreement is officially over in early June.

ATTACKS ON COLLECTIVE BARGAINING

Lastly, it would not be a Jay McDonald report if we did not talk about Right to Work and collective bargaining. We must always be vigilant about maintaining our <u>UNION RIGHTS</u> because the Buckeye Institute; American Legislative Exchange Council (ALEC) and other anti-union groups are still pushing for things like:

 SB 1 was introduced and was passed into law. We Are Ohio says Senate Bill 1 represents the worst attack on workers since SB 5. SB 1 bans strikes and limits bargaining subjects for unionized workers at Ohio's public colleges and universities.

- SB 8 (Sen. Steve Huffman R-Tipp City) bans release time for public employee unions. This solution in search of a problem was not asked for by any employer. It is modeled after an Arizona law that passed in 2022.
- The federal government has attempted to eliminate unions and union contracts. Affected agencies include the Departments of State, Defense, Veterans Affairs, Energy, Health and Human Services, Treasury, Justice and Commerce and the part of Homeland Security responsible for border security
- West Virginia passed a law eliminating civil service protections and grievance procedures for newly hired state employees.
- Utah passed a complete Senate Bill 5 type bill, outlawing public employee collective bargaining. Public employees in Utah fought back, forming the Protect Utah Workers coalition and collected enough signatures to place the issue on the ballot. The Governor has not yet decided if the election on this referendum will be in 2025 or 2026.

ALEC's 2025 Essential Policy Solutions proposes model bills for defunding public sector unions, preempting local labor laws, eliminating occupational regulations, and entrenching precarity for workers by expanding the ranks of independent contractors.

Among the anti-labor model bills ALEC is pushing this year are the "Union Recertification Act," first adopted in 2018 to make it harder for public sector workers to keep their unions; the "Fair and Accountable Public Sector Authority Act," adopted in 2021 to ban public sector collective bargaining; and the fact that ALEC keeps proposing the same positions over and over tell us that they are still popular within the ALEC circles and still a threat to public sector union members.

Right to work legislation inspired by ALEC bills was introduced in New Hampshire (HB 238), where it has already been defeated after significant outcry from organized labor; Maine (LD 187), where the lead bill sponsor is an ALEC member; and Montana (SB LC4333). None of these bills were successful. In Virginia, lawmakers were considering adopting right to work policy as a constitutional amendment, but the proposal was killed in the Virginia Senate along a party-line vote.

Bills outlawing automatic dues deductions — an idea promoted by ALEC since at least 1988, and already successfully implemented in Florida, Arkansas, and Kentucky, among other states — have been introduced this year in North Carolina (SB 47) and Montana (SB 277). The North Carolina and Montana bills were not successful.

Americans for Prosperity (AFP) and ALEC are behind these bills all across America. AFP was behind the successful effort to end qualified immunity in New Mexico as well.

Many states will attempt to split unions away from the rest of organized labor by exempting the public safety workers from the onerous bills passed that are designed to gut labor. While I am glad that sometimes our members are spared from the harmful impacts of these anti-union laws, exemptions are a slippery slope that will eventually place our members out on a limb all by themselves.

Always remember: Right to Work is WRONG!!!

LEADERSHIP GOALS

I am proud to continue to fight for the members of the FOP here in the Buckeye State. I am grateful that I can play a role in defending cops. Standing up and speaking out on behalf of the officers of the great state of Ohio is something that I will never stop doing and there have been plenty of opportunities to do just that since our conference last year.

I promised the members of the Fraternal Order of Police of Ohio that the state lodge and its leaders would be more active, more aggressive and more communicative. The evidence shows that we have kept those promises.

In the last year, members of the State Lodge Executive Board have attended local lodge meetings in every district and in every corner of the state. We have included more Trustees in the business of the FOP, by sending them to National FOP events and trainings. We have visited and participated in local lodge meetings, memorial services, social events and fundraisers. We have been to Washington D.C. on three occasions to lobby for FOP priority legislation since the last FOP of Ohio conference one year ago. There is no doubt we have been more active.

We have been more aggressive, standing up for and speaking out on behalf of our Brothers and Sisters across Ohio. We have done so at city councils, the state legislature and congress. We have made our case to Ohioans through the media on topics that are important to our members. A perfect example of the FOP of Ohio being more aggressive is that we went after GoFundMe for allowing online fundraisers for the killer of Deputy Henderson, and we were successful in getting those taken down!

We have increased communication from the state lodge to the membership by leaps and bounds. We have started video updates to reach out to our members. We have developed and instituted a monthly newsletter, regular

Zoom meetings with members, increased email communication and social media utilization. The reach of our FOP of Ohio Facebook page has grown by 93.7% from August 1 of 2024 to the present over the same period the preceding year.

IN CONCLUSION

I want to thank my fellow members of the FOP of Ohio Board of Trustees. I am thrilled to be able to work with them on behalf of the members. I am grateful for the work of our staff; they work hard for our members every single day and I appreciate all that they do for us.

Lastly, I want to thank the local FOP leaders who take on the difficult job of representing the membership within their own departments. Often, they take on these jobs and risk parts of their career to do so. Local leaders have the most important job in the FOP, taking care of the men and women who protect and serve, and we all owe them our gratitude for their hard work.

Report of State Vice President TJ Assion

Sisters & Brothers,

Welcome to District 9 for the annual Ohio FOP Conference. I look forward to spending time with all of you over the next few days. There will be a lot of business that we must accomplish at this year's conference and all of it is for the betterment of our members as it is our goal to keep moving forward.

This past year I have traveled around our state, from Lake Erie to the Ohio River, from the Pennsylvania line to the Indiana line, attending local lodge meetings and keeping the members as informed as possible. In November and again in December, I went with President McDonald to Washington DC to lobby our Ohio Congressional Delegation to pass the Social Security Fairness Act which all of you are aware was passed by both chambers and signed into law by the President. I attended our National Day on the Hill with about twenty (20) members from Ohio where we met with almost all of our Congressional delegation in an effort to push national legislation important to law enforcement officers. I attended both of our Ohio Lobby Days, where we met with our State Representatives and State Senators in our efforts to push legislation we feel is critical to our members, especially with regards to our pensions.

I attended the National Labor Summit Training in Las Vegas and I believe we should spend our time and resources at other training that does not seem like a sales pitch for a private vendor. While Artificial Intelligence (AI) is fast growing and has already been incorporated into our profession and , indeed, in some our collective bargaining agreements, attending training on this new and growing concept can and should be done regionally, with a more concise curriculum. Las Vegas is expensive and in my opinion the quality of the training was not worth the cost.

I have worked on getting our members who are employed with both Columbus and Cincinnati Sate Community Colleges to transfer retirement systems from SERS to OPERS. There are several roadblocks we are still trying to overcome to make this happen. Title 145 of the Ohio Revised Code governs the legalities associated with OPERS. There are currently one hundred and eighty three (183) separate subsections to this law. An amendment to this code would need to happen through the legislature in order to bring these members into OPERS. We would also need the leadership from both schools to agree to the move. The contribution rates would have to be adjusted as the rates are higher in OPERS. And we also discovered that the same service time credit issue that we have been debating for years with OPERS and OP&F exists between OPERS and SERS – this too would need addressed.

From the time that I assumed my role on our Board, I have actively been pushing to have DROP become available for our members in OPERS (currently HB73). This would be a benefit that has been available to our members in OP&F for the past twenty-five (25) years

and for the Troopers since the beginning. This legislation comes at no cost to the State budget and there is a proven cost savings to the system as a whole, as the members engaged in DROP are not drawing their health care stipend and the system would make some revenue on our investments. Our State Representatives and Senators are either in favor of or are indifferent to the passing of this legislation. The only entity that has been standing in the way of passing this legislation is the OPERS Board. They have been telling the legislature that it will cost the system \$10 million to implement DROP and have been insistent that the availability of the Partial Lump Sum Option Payment (PLOP) is a better benefit. It is our contention that our members deserve the choice to either enter DROP or take the PLOP. We believe that DROP would be a better tool for recruitment and retention and would help agencies keep experienced personnel on the job while newer Officers and Deputies are brought onboard.

In May Second Vice-President Bill Saringer (Salinger), Legislative Committee Chair Mike Taylor and I attended a round table discussion with U.S. Senator Bernie Moreno and U.S. Secretary of Labor Lori Chavez-DeRemer along with leaders from OAPFF and the Building Trades. We discussed the possibility of the Labor Department sponsoring an apprenticeship program for law enforcement. We also encouraged Senator Moreno to pass Senate Bill 122 – the Qualified Immunity Act of 2025 and re-iterated our position for the removal of the federal consent decree over the Cleveland PD. This consent decree has been in place for ten (10) years and costs the city of Cleveland \$40 to \$45 million per year. This money would be better spent hiring and promoting the necessary personnel for the Cleveland Police Department, which has seen a drastic reduction in numbers.

A commitment that this board made to the members was to implement an increase in the manner by which we communicate, both in quantity and quality. I am proud to say that this is a commitment that we have not only kept, but we anticipate doing more. We have updated our website making it easier to navigate. While no information has been lost, we have spilt the website into 2 (two) separate sections — a section for the FOP and a section for the Ohio Labor Council. The website has a member's only section where all Ohio FOP members can sign-up and receive information from your state board in as close to real time as possible. There is a smartphone app associated with our website where, if you are a registered member, you can receive alerts sent directly to your phone regarding pertinent business. President McDonald puts out video newsletters on a regular basis informing the members of current events. These newsletters are also in print form where you can read them at your leisure. Our social media footprint has grown tremendously. Your state board has been hosting quarterly Zoom meetings for each District where the most up-to-date information is presented and the members who "zoom in" can ask questions.

I have also been researching several software systems as a possible means to make our work easier, cost efficient, time efficient and more professional. These systems include electronic voting systems, which must be secure, auditable and tamper-proof. I have also been researching different systems whereby all conference registration of delegates, alternates and guests is done online through a secure portal. No action with regards to purchasing and implementing these systems has been taken, as our Constitution and Bi-Laws would need updated.

Let me close by saying "Thank You". I continue to be humbled by all of you for choosing me to be your State Vice-President. I have been and I will continue to put in the work for the betterment of our organization and all of our members. It is a responsibility that I do not take lightly. I look forward to all the great things we will do for our Brothers & Sisters in Ohio.

In the month of May, we saw multiple violent attacks against Peace Officers in Ohio. Morrow County Deputy Daniel Weston Sherrer and Hamilton County Deputy Larry Henderson were both killed in the line of duty. Multiple others were shot. This led to the creation of a new effort from the Ohio FOP which we named "Protect Ohio Police". Through this effort, the Ohio FOP will work to hold Ohio's Judges, Prosecutors, and Politicians accountable when they make rulings and decisions that place our members and the public in danger. The FOP is the organization that is leading the effort to speak up for all law enforcement officers in the state of Ohio.

I attended the Ohio Peace Officers Memorial Ceremony at OPOTA. I also attended the National Peace Officers' Memorial Service at the U.S. Capitol where I serve on the National Police Memorial Committee. It is an honor to play a small role in honoring our heroes who made the ultimate sacrifice. I encourage everyone to attend these memorial services. It is important we uphold our promise to the survivors to "Never Let Them Walk Alone".

In addition to the memorial services, I attended both the Fall and Spring National FOP Board Meetings. I also attended the Day on the Hill event where we spent a couple of days lobbying our elected Representatives and Senators in Congress on the National FOP legislative priorities. I have continued to travel around the state of Ohio attending local lodge meetings and events.

As I promised when I campaigned, I began looking at ways to make our Ohio FOP operation more efficient and effective. This year, we began paying our bills online, saving time and money. We also spread out our "war chest" money into CD's so our money would be better protected and grow at a faster rate until the day comes that we need to use it.

I want to thank the Ohio FOP staff for their work on behalf of our membership. Denise Young, Peggy Middendorf, Diane Fuchs, Aaron Crawford, Rob Hawley and Mike Weinman all deserve recognition for the work they do on our behalf. Thank you all! In fact, the changes we made that I spoke about in the paragraph above were all accomplished due to the work of those listed above. Please take time to say thank you as you see them around the conference this year. While each one of them deserves our thanks, I would like to take a moment to show special appreciation to Denise Young. Denise constantly goes above and beyond for the Ohio FOP. She fields calls and emails on weekends and evenings. Denise, thank you for helping to guide the FOP of Ohio! We are blessed that you care so much about our membership.

This past year, I began working on the Legislative Committee. While I have attended our Ohio Lobby Days in the past, that was the extent of my prior experience. Time sure flies because in one year, I coordinated a total of three Lobby Days at the Statehouse. I want to thank Mark Emde who worked with me in setting those events up. Thank you to everyone who attended our Lobby Days. I know it takes an entire day to come to Columbus and attend the meetings, but those grassroots meetings are impactful on our state legislators. While we have work ahead of us on our priority legislation, we have been making progress. As we saw with the Social Security Fairness Act, staying focused and active with our lobbying efforts is the key to getting legislation passed.

If you are a Lodge President or Secretary, please make sure you have a current phone number and a personal email address (not a work email) on file with the State FOP office. We send out important information that is time sensitive (legislative updates, conference registration information, notices when local lodges have issues with the IRS). Workplace email networks often block our group emails, preventing you from seeing this information. Reach out to myself or Densie Young to ensure you have a good email on file with the State.

Local Lodge Secretaries, be on the lookout for a new National FOP membership database. The National FOP is in the process of transitioning to a new membership database system. The transition will most likely be happening around our State and National Conferences. Like any new system, it will take some time for us all to learn the system and iron out any "bugs".

In December, we became aware of the issues our members were having with Thin Blue Line Benefits. We had Thin Blue Line Representatives attend our January Board Meeting to discuss the issues and answer questions from our Board and our membership. In addition, we met with Thin Blue Line leadership several times after January to get these problems fixed. However, the problems have continued. At the May Ohio FOP board meeting, the board voted to terminate the marketing agreement with Thin Blue Line Benefits.

Thank you to 9th District Trustee Jon Halusek, President Ken Kober and the members of the 9th District for hosting the conference! I have had several planning meetings with them and I know how much work has gone into hosting this conference. Thank you brothers and sisters! I wish everyone a productive and enjoyable next few days while we conduct the business of the Lodge.

Brothers and Sisters, I speak to you now with a heavy heart. As I sit here writing this report, members of my local lodge are preparing to honor the loss of one of our own. On June 23rd, his family, members of the Akron Police Department and Lodge #7 lost an avid member of their

lodge. Brother Clay Cozart, whom many of you know from his work with the FOP and the OP&F pension board, passed away at his home while sleeping. Clay was just 59 years old.

Clay will be remembered not just as the former President of FOP #7, but as a staunch advocate for police officer's rights. During a time of civil unrest, Clay endured threats from would-be protesters and scrutiny from those within his city administration but never wavered in his commitment to the protection of the members of his lodge. He was a friend and mentor to many. His legacy will not soon be forgotten.

Lodge #7 continues to battle with a city administration that loves to speak from both sides of their...mouth. Both the mayor and city council preach their support for the police while in private, but their actions do nothing but demonstrate the opposite in public. Constitution and Bylaws Report

Delegates of the 89th Fraternal Order of Police of Ohio State Conference. Thank you to all the Lodges for complying with the procedure for submitting proposed changes to their C&B. Not to be redundant but listed below is the procedure for proposing amended changes to your local C&B. This is important for several reasons. First, timeliness to comply with Article X of our own State C&B and allowing the C&B committee enough time to review submissions. Secondly, per our state procedure, the submitting subordinate Lodge notifies the **State Secretary** of the changes. The State Secretary then notifies the local **District Trustee** that a lodge within their district has submitted proposed changes to their C&B. This creates awareness and allows the District Trustee to get involved especially if the submission conflicts with the National or State C&B. Finally, once complete/approved the Lodge will provide a clean copy (with the changes) to the State Secretary to keep Lodge files current. Below are the **REQUIRED** procedures for proposed C&B changes for subordinate Lodges:

- 1. Lodges with changes to their C&B <u>must submit the entire C&B with changes indicated to the State Secretary</u>.
- 2. The changes will be made by striking out the old language followed by the new language which will be underlined.
- 3. Any changes to a lodge's C&B will be submitted to the **State Secretary** no later than 30 days prior to a meeting or conference. If changes are received later than 30 days prior to a meeting or conference, they will be held until the next meeting or conference (no exceptions).
- 4. The **State Secretary** will notify the **District Trustee** of the submission and provide him/her with a copy. A copy of the C&B will be emailed to the C&B committee for review.

- 5. Committee will review any changes and the **committee chairman will contact** the trustee on whether the changes are acceptable and not in conflict with the National or State C&B.
- The trustee will then determine whether the Lodge needs to make changes or if the changes will be presented to the State Board at the next meeting for approval.
- 7. Once approved at a meeting or conference, a clean complete/approved copy of C&B will be given to the **State Secretary** for the Lodge file. A copy of the approved C&B will be sent to the Lodge making original submission.

Next, you will notice in the conference booklet two (2) amendments to the State Constitution proposed by the board of trustees of the Fraternal Order of Police of Ohio. They are:

Amendment 1:

- Article V-Board of Trustees Section 3-Meetings and Quorum
- Article VI- Annual Conference Section 1 Governing Body
- Bylaws Article II- Presidennt Section 1 Meetings and Legislative Chairman

Synopsis: Article would allow meetings of the board of trustees and even the State conference to be held via virtual platform under certain circumstances.

Amendment 2:

• Bylaws Article XIX-Annual Conference Section 4: Election of Officers

Synopsis: Attempt to streamline the voting process to become more efficient while maintaining the integrity and credibility of the process. Gives the election committee appointed by the President the opportunity to utilize an electronic voting system, printed ballot process or a combination of both.

Both were timely and read by Secretary Parker at the Spring Board meeting. Amendments were submitted to the Constitution and Bylaws committee for review. See amendments in the conference booklet for further details.

The Critical Incident Response Service (CIRS) is a consortium of Critical Incident Stress Management (CISM) peer support teams throughout the state. Currently there are 45 teams registered with the Ohio CISM Network, and a couple who are not.

CIRS has been able to provide trainings throughout the state, so thank you to all of you present who are members of one of the CISM peer support teams in Ohio.

For the last 13 years, CIRS has been entirely funded by the FOP of Ohio Foundation, at zero cost to your members and only recently has there been any charge to first responders taking training. So, to those of you who support the Foundation and to Rob for the fundraising opportunities, thank you.

Ohio Peace Officer Training Commission Report



Ohio has made comprehensive changes to the training in training academies that will begin this month, teaching an updated curriculum that prioritizes modern-day policing issues. The changes reflect the recommendations of the Blue Ribbon Task Force on the Future of Police Training, commissioned by Attorney General Dave Yost in 2023.

Effective July 1, academies will introduce the updated curriculum that is mandatory by Jan. 1, 2026. The changes reflect the task force's vision for a modernized, skills-based officer training program.

Under the previous OPOTC curriculum, a cadet had to take a minimum of 740 hours of training to obtain certification. Within that curriculum, however, the task force found that some courses being taught did not add sufficient value to a new officer's basic education.

In the new curriculum, cadets to any Peace Officer Basic Training (POBT) academy will now see 72 hours of outdated curriculum replaced with practical, high-stakes training tailored to today's law enforcement environment, including new courses on active shooters and threat response, critical decision-making, crisis mitigation and de-escalation, communications and mediation, and incident debriefs.

Courses removed or reclassified (72 hours total):

Blue Courage (16 hours): Post-graduation offering

First Aid, CPR, AED (8 hours): Online prerequisite

ICS/NIMS (8 hours): Online prerequisite

NHTSA Speed Measuring Device (40 hours): Post-graduation elective

New training topics (72 hours total):

Basic & Interpersonal Communications & Mediation: 44 hours

Incident Debrief Training: 4 hours

Active Shooter/Threat Response + Duty to Render Aid: 8 hours

ICAT (Critical Decision-Making, Tactical Breathing, Crisis Mitigation, De-escalation): 16 hours

Also, the task force introduced a modified graduation fitness standard that was implemented after OPOTC approved it in May of 2024. Although entry-level standards remain unchanged, cadets are eligible to graduate if they pass two of the three fitness test components (sit-ups, push-ups, 1.5-mile run), as long as they meet at least 75% of expected progress in the third component.

In the year since this change, 91 additional cadets have graduated — officers who would have been disqualified under the previous standard — allowing for more officers to enter our profession.

PENSION COMMITTEE REPORT Mark Drum, Chairman

Brothers and sisters, it is my privilege to serve on the Ohio Police and Fire Pension Board (OP&F). One of the pleasures of this service has been the excellent board members that I serve with. The board is comprised of three representatives from fire (2 active and 1 retiree), three police representatives (2 active and 1 retiree) and three of the best investment experts that a pension system could wish for. The investment experts are appointed (1 by the governor, 1 by the legislature and 1 by the State Treasurer).

The three police representatives are Clay Cozart, Brian Steel and me. We each have a long history of leadership roles within the FOP. I am proud of the fact that the FOP, as the strongest representative for law enforcement officers in the state of Ohio, has been instrumental in assuring that the three police representatives on the OP&F Board are FOP members.

For 2024, the OP&F Pension fund had the best investment returns of the five state pension systems. The investment return was 10.66%, which far exceeded the assumed rate of return which is7.5%. As of June 17th, the OP&F investment portfolio was valued at over \$19.5 billion, a record high.

The OP&F investment performance for the quarter ending March 31, 2025, ranked in the <u>top one</u> <u>percent</u> of 544 public pension plans throughout the U.S. as measured by Investment Metrics, an industry leading provider of performance analytics.

OP&F's strong performance was not only notable during the quarter but also over longer periods, ranking in the top one percent for the trailing one-year, top nine percent over five years, and top seven percent over ten years where 447 funds were measured. Over the trailing 10 years, OP&F outperformed 93 percent of the other funds in the universe while experiencing less volatility in its returns than 76 percent of those same funds.

OP&F's independent actuary, CavMac, presented its annual report on the system's funding status at the Board of Trustees meeting on Oct. 30, 2024. Despite chronic underfunding of police contributions, the actuarial valuation showed that OP&F's funding period is now 29.77 years, which is still in compliance with Ohio's requirement of 30 years or less. The latest funding period is a slight increase from Jan. 1, 2023, when it was 26.71 years. The funding period shows the time it will take to fully pay all pension obligations if assumptions in place are met. Our OP&F actuaries are currently preparing the 2025 accrual report which will be provided to the legislature. I believe there is a good chance that the system will be over the 30-year requirement.

The OP&F System has been underfunded, and the employer contributions must increase. HB280 was introduced in the Ohio House in June to address this funding. I'm sure the legislative committee will delve into the game plan to get this legislation passed during the current session. The FOP, OAPFF and OP&F made a valiant attempt to include the fix in the state budget bill (an amendment introduced by Sen. Andrew Brenner) but it did not make the cut in the budget passed by the Senate.

However, a late-night amendment that was added, by the conference committee, would change the makeup of the State Teachers Retirement (STRS) Board. The amendment would reduce the number

of STRS Board elected teacher positions from seven down to three and add more political appointments to the board. This will give the governor and politicians more control over the teachers' pension system. While I do not have a strong concern that the legislature would try to do the same thing to OP&F, it certainly opens the door to future changes.

As I was preparing this report, I received a phone call regarding the tragic passing of Clay Cozart. I contacted Clay, in early 2024, and asked him to seek election to the OP&F Pension Board. Clay was a good friend and, as I knew he would be, he was a perfect fit for the OP&F Board. His passing is a profound loss to the OP&F Board and the members he served. His impact will resonate with the brothers and sister he worked with, the Akron community, the FOP and the OP&F.

Scholarship Committee

I want to personally thank the committee members from the FOP for their hard work, Frank Alesaino - Lodge 4, Jeff Herold - Lodge 18, John Boykin – Lodge 139, Jared Donoho – Lodge 104, Jeremy Payne – Lodge 143, and Karen Cydrus -Lodge 59.

Opinion

Notes to Consolidated Financial Statements December 31, 2024 and 2023

Nature and Scope of Business

The Fraternal Order of Police of Ohio, Inc. (FOP), a state lodge chartered by the Fraternal Order of Police, a national police organization, was organized in 1934. The FOP is dedicated to the advancement and protection of law enforcement officers, the promotion of improved law enforcement methods and the teaching of respect for law and order.

Entities that are related to the FOP are as follows:

- 222 Corporation, a wholly-owned not-for-profit subsidiary that owns the office building where FOP is located.
- The Fraternal Order of Police Ohio Labor Council, Inc. (OLC), a not-for-profit organization, is not under the direct control of the FOP and therefore is not consolidated with the FOP and Subsidiaries. OLC is dedicated to the betterment of law enforcement personnel through the representation of its members in collective bargaining and other labor relations matters.
- Fraternal Order of Police of Ohio Foundation, Inc. (FOPF), a not-for-profit
 organization controlled by the FOP that was formed for the purpose of providing support
 and financial aid to persons in need, including but not limited to, Special Olympics,
 Easter Seals, law enforcement personnel in need, survivors of law enforcement officers
 killed in the line of duty or any other charity as so approved.

Summary of Significant Accounting Policies

Principles of Consolidation

The consolidated financial statements of the FOP and subsidiaries (the Organization) include all accounts of FOP, 222 Corporation and FOPF. All significant intercompany balances and transactions have been eliminated in consolidation.

Basis of Consolidated Financial Statements

The Organization's policy is to prepare its consolidated financial statements using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. That basis differs from accounting principles generally acceptable in the United States of America in that certain revenues are recognized when the services are provided rather than when earned and certain expenses are recognized when paid rather than when the services are received. Under the modified cash basis of accounting, related party receivables and payables are accrued. Accordingly, the accompanying consolidated financial statements are not intended to present the financial position and changes in net assets in conformity with accounting principles generally accepted in the United States of America.

Notes to Consolidated Financial Statements December 31, 2024 and 2023

Summary of Significant Accounting Policies (continued)

Financial Statement Presentation

The Organization reports information regarding its financial position and activities according to three classes of net assets:

- <u>Net Assets without Donor Restrictions</u> Net assets are not restricted by donor-imposed restrictions and are available for use in the Organization's ongoing operations.
- Net Assets with Donor Restrictions Net assets are limited as to use by donor-imposed restrictions that either expire by passage of time, can be fulfilled and removed by action of the Organization pursuant to those restrictions or are permanently restricted as to use and generally allow only the use of earnings for restricted purposes.

The net assets of the Organization are without donor restrictions at December 31, 2024 and 2023.

Use of Estimates

The preparation of consolidated financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the consolidated financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Liquidity and Available Resources

The FOP has \$2,181,106 of financial assets available within one year of the balance sheet date to meet cash needs for general expenditure consisting of cash of \$1,881,128 and marketable securities of \$299,978. None of the financial assets are subject to donor or other contractual restrictions that make them unavailable for general expenditure within one year of the balance sheet date. The FOP has a policy to structure its financial assets to be available as its general expenditures and liabilities come due.

Marketable Securities

Marketable securities are stated at fair value determined by quoted market prices and represent shares in mutual funds. Gains and losses on these investments are reported in the statements of support, revenue, expenses and net assets – modified cash basis as increases or decreases in unrestricted net assets. Marketable securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain marketable securities, it is at least reasonably possible that changes in the values of marketable securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of assets, liabilities and net assets – modified cash basis.

Notes to Consolidated Financial Statements December 31, 2024 and 2023

Summary of Significant Accounting Policies (continued)

Property and Equipment

Property and equipment are carried at cost. Depreciation is calculated using accelerated or straight-line methods over the estimated useful lives of the respective assets. Assets purchased but not placed in service are capitalized and depreciation is not recorded until the assets are placed in service. Property and equipment that are donated are recorded at fair market value on the date of receipt. Maintenance and repairs, which do not improve or extend the estimated useful lives of the respective assets, are expensed as incurred. Major improvements or betterments are capitalized. When property and equipment are sold or retired, the related cost and accumulated depreciation are removed from the accounts, and any gain or loss is included in income. Property and equipment are depreciated over their estimated useful lives as follows:

Building and improvements	10	- 40	years
Office equipment	5 -	- 7	years
Computer equipment	3 -	- 7	years
Furniture and fixtures	5 -	- 7	years

Total additions during 2024 and 2023 were \$36,185 and \$60,961, respectively.

Impairment of Assets

The carrying value of long-lived assets is reviewed for impairment whenever events or circumstances indicate the amount of the assets may not be recoverable. When an indication of impairment is present and the undiscounted cash flows estimated to be generated by the related assets are less than the assets' carrying amount, an impairment loss will be recorded based on the difference between the carrying amount of the assets and their estimated fair value. There were no such impairment adjustments at December 31, 2024 or 2023.

Rental Revenue

Rental revenue is recognized when paid by tenants.

Federal Income Taxes

The FOP, 222 Corporation and FOPF are exempt from federal income taxes under Sections 501(c)(8), 501(c)(2), 501(c)(3) and 501(c)(3), respectively, of the Internal Revenue Code.

A provision, if applicable, has been made in the consolidated financial statements for federal income taxes by applying statutory income tax rates to income before income taxes.

Notes to Consolidated Financial Statements December 31, 2024 and 2023

Summary of Significant Accounting Policies (continued)

Federal Income Taxes (continued)

The Organization accounts for uncertainty in income taxes in its consolidated financial statements as required under Financial Accounting Standards Board (FASB) Accounting Standards Codification, Accounting for Uncertainty in Income Taxes. The standard prescribes a recognition threshold and measurement attribute for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return. The standard also provides guidance on de-recognition, classification, interest and penalties, accounting in interim periods, disclosure and transition accounting. Management determined there were no material uncertain positions taken by the Organization in its tax returns.

Fair Value Measurements

The modified cash basis of accounting established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Cash

Cash includes cash on hand and demand deposits held by banks. Cash is maintained in seven accounts at two financial institutions and, at times, balances may exceed federally insured limits.

Note Receivable - Related Party

From 1984 through 1986, the FOP rendered services totaling approximately \$97,000 on behalf of the OLC. In January 1997, a promissory note agreement was signed between OLC and FOP for \$97,493. The note agreement is payable by OLC in annual payments of principal and interest of \$1,000 beginning July 1997 and through July 2097. The note has been recorded in the accompanying consolidated financial statements at its present value of \$12,072 and \$12,076 at December 31, 2024 and 2023, respectively, using an interest rate of 8.25%.

Long-Term Debt

222 Corporation entered into a term note payable in the amount of \$632,408 with a financial institution in December 2017 which is secured by the property. Monthly payments of principal and interest in the amount of \$4,758 were due through December 2032. During 2019, 222 Corporation began making biweekly payments of \$2,379 on the note payable. Interest is calculated at a fixed rate of 4.25%. Outstanding borrowings on the note at December 31, 2024 and 2023 were \$350,595 and \$398,260, respectively.

Accounts Payable - Related Party

Accounts payable – related party consists of overpayments of amounts owed by FOP to OLC for rent, personnel, postage, computer usage and other charges under a service agreement.

Fair Value Measurements

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by FOP at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although FOP believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Leases

The Organization leases office space to the OLC and other unrelated parties under operating lease agreements. The lease terms expire at various dates through 2025. The leases include a monthly base rent and a portion of the Organization's operating expenses, as defined in the agreements. Effective January 1, 2020, the lease with OLC was extended until December 31, 2029. Initial monthly payments from OLC are \$4,081 and will increase 2% each year until maturity.

Labor Agreement

Approximately 50% of FOP's employees are covered by a collective bargaining agreement that expires in December 2026.

Retirement Plan

The Organization has a salary reduction plan (401(k) Plan) for substantially all full-time employees who have attained the age of 18 and completed six months of continuous service. Contributions are held for the exclusive benefit of the employees. Annual contributions by the Organization to the 401(k) Plan are discretionary. Contributions of \$10,827 and \$6,073 were made in 2024 and 2023, respectively.

Related Party Transactions

In addition to the office space described above, the Organization leases certain office equipment and furniture to the OLC under annual operating leases. Total rental income received from OLC in 2024 and 2023 was \$64,033 and \$63,243, respectively.

The Organization provides various administrative and technical services to the OLC under a service agreement, which extends through July 2027. During 2024 and 2023, the Organization received management fees of \$272,220 and \$324,330, respectively, from the OLC. Additionally, expense reimbursements of \$584,630 and \$469,800 were received from OLC during 2024 and 2023, respectively.

Subsequent Events - Date of Management's Evaluation

Management has evaluated subsequent events through the date of the Independent Auditor's Report, the date on which the consolidated financial statements were available to be issued.

Section Seven Amendments

AMENDMENTS TO THE CONSTITUTION AND BYLAWS PROPOSED BY THE BOARD OF TRUSTEES OF THE FRATERNAL ORDER OF POLICE OF OHIO, INCORPORATED

WHEREAS, the Fraternal Order of Police of Ohio, Incorporated ("FOP") is committed to maintaining continuity of operations and responsiveness to the needs of its members under all circumstances;

WHEREAS, the FOP recognizes the importance of conducting business effectively during emergencies or other extraordinary events;

WHEREAS, advances in communication technology allow for secure and inclusive virtual participation in meetings;

THEREFORE, be it resolved, that the following amendments to the Constitution and Bylaws of the Fraternal Order of Police of Ohio, Incorporated, are proposed by the Board of Trustees to be considered at the Annual Conference in 2025:

CONSTITUTION ARTICLE V – BOARD OF TRUSTEES

Section 3 – Meetings and Quorum

The Board of Trustees shall meet at the call of the President. A majority of the Board of Trustees shall constitute a quorum for the conduct of its business. A majority vote of all members present shall be necessary for the taking of any action unless otherwise specifically provided in this Constitution.

Meetings of the Board of Trustees, including the State Conference, may be conducted by means of a virtual platform under the following circumstances:

- In the event of a natural or man-made disaster;
- When a state of emergency is declared;
- During instances of large-scale civil unrest; or
- When deemed necessary by the President and approved by a majority of the Board of Trustees.

The meeting Chair/designee shall ensure that only duly authorized members are permitted access to the virtual meeting. Procedural requirements, such as the recording of attendance, minutes, and the conduct of votes, shall apply equally to virtual meetings.

There shall be no other changes to the language in Article V of the Constitution.

ARTICLE VI – ANNUAL CONFERENCE

Section 1 Governing Body The annual conference shall be the governing body of the Ohio State Lodge and shall be held during the months of June or July at the direction of the State President. In any year that the biennial conference of the Grand Lodge of the National Fraternal Order of Police is to be held in a city in Ohio, the Ohio annual conference may be held in either July or August subject to the call of the State President.

The annual conference may be held in person or through a secure virtual platform that ensures full participation by registered delegates, including the ability to vote, speak, and make motions, when approved by the President with consent of the Board of Trustees and under circumstances such as declared emergencies or extraordinary events.

There shall be no other changes to the language in Article VI of the Constitution.

BYLAWS ARTICLE II – PRESIDENT

Section 1 Meetings and Legislative Chairman

The President may:

a. Call regular meetings of the Board of Trustees and shall call a special meeting upon the written request of not less than four (4) members of the Board. The Secretary shall send a notice of any special meetings via email, with delivery confirmation and read receipt requested to each member of the Board stating the time, place and date of the meeting and the business to be considered, unless waiver of such notice is signed by all of the members of the Board of Trustees. The President may call meetings of the Board of Trustees to be held in person or by secure virtual means that allow all members to participate simultaneously.

With the advice and consent of the Board of Trustees appoint a legislative chairman who shall promote legislation in the furtherance of the purposes of the Fraternal Order of Police and oppose legislation detrimental thereto, except for certified State Issues determined directly by a vote of Ohio voters in a general election. The legislative chairman may call upon any officer of the State Lodge and any officer or member of a subordinate lodge to assist him in the performance of his duties.

With respect to any certified State Issue being placed before Ohio voters in an election, all decisions concerning the endorsement or opposition of said issue shall be determined by the delegates at the annual Ohio State conference. If a vote of the delegates is unattainable due to a timing of an election, all decisions concerning the endorsement or opposition of any state issue shall be decided by a vote of the State Board of Trustees.

The legislative chairman and all persons authorized to assist him in the performance of his duties shall be compensated at a rate established by the Board of Trustees and shall be reimbursed for all expenses incurred in the performance of official duties. The legislative

chairman shall present to each annual conference, a written report of his activities which the Secretary shall make available to the delegates.

The legislative chairman shall have the authority to incur obligations for and on behalf of the State Lodge in the performance of his duties subject to review by the Board of Trustees, except for certified State Issues determined directly by a vote of Ohio voters in a general election.

There shall be no other changes to the language in Article II of the Bylaws.

AMENDMENT TO THE CONSTITUTION AND BYLAWS PROPOSED BY THE BOARD OF TRUSTEES OF THE FRATERNAL ORDER OF POLICE OF OHIO, INCORPORATED

WHEREAS, the Fraternal Order of Police of Ohio, Incorporated ("FOP") is committed to modernizing its election procedures, and

WHEREAS, the FOP seeks to streamline the voting process to ensure faster, more efficient elections, and

WHEREAS, the FOP believes maintaining the highest integrity in voting is essential to the credibility of the election process, and

WHEREAS, the use of secure electronic voting enhances the accessibility, security, and accuracy of elections while maintaining an option for a printed ballot for those who request it;

THEREFORE, be it resolved, the following proposal to amend Article XIX Section 4 of the Constitution and Bylaws of the Fraternal Order of Police of Ohio, Incorporated, is hereby proposed by the Board of Trustees to be voted upon at the annual conference in 2025:

<u>BYLAWS</u> ARTICLE XIX – ANNUAL CONFERENCE

Section 4. Election of Officers

The election shall be conducted by secret ballot. The Elections Committee, appointed by the President, may authorize using a secure electronic voting system, a printed ballot process, or a combination thereof, as appropriate. Each delegate, or his/her alternate, shall receive either an electronic ballot with instructions for secure submission or a printed ballot listing all nominated candidates.

If the voting is done using a secure electronic voting system, delegates who wish to vote by printed ballot must submit a written request to the Elections Committee no later than the close of business on the first day of the Conference. Printed ballots shall be issued to verified requesting delegates and cast in a secure ballot box.

The Elections Committee shall oversee all aspects of the voting process, certify the results, and report the outcome to the delegates.

.Each delegate or his alternate shall be furnished one printed ballot containing the names of all candidates. All voted ballots shall be deposited in a ballot box and the results certified by the elections committee which the President shall appoint.

There shall be no other changes to the language in Article XIX of the Bylaws.
